IN 2018 WE COORDINATED WITH CHAMBERS OF COMMERCE AND MUNICIPAL ASSOCIATIONS TO FIGHT A RELIGIOUS PREEMPTION BILL FILED IN THE STATE HOUSE THAT WOULD HAVE GIVEN BUSINESSES AN UNFETTERED LICENSE TO DISCRIMINATE EVEN IN LOCALITIES HAVING NONDISCRIMINATION ORDINANCES IN PLACE. WE ENGAGED CITIZENS FROM ACROSS THE STATE TO JOIN US IN TALLAHASSEE FOR OUR ANNUAL LOBBY DAYS, WHERE THESE GRASSROOTS ACTIVISTS MET WITH ELECTED LEADERS FROM BOTH CHAMBERS AND BOTH MAJOR POLITICAL PARTIES. AFTER NEARLY 80 SUCH LEGISLATIVE MEETINGS, THE BILL FAILED TO BE HEARD IN COMMITTEE. (CONTINUED ON SCHEDULE O)
